About Us

The Malone Golf Club is a 36-hole golf facility with two Championship Courses; the East and the West. The Club is a membership-owned, semi-private facility with a modern clubhouse including locker rooms, a member's bag storage room, a fully stocked pro shop, and a full-service restaurant and banquet facility.

Annual Membership Categories

Individual Membership: (1) Adult age 31 or older

Family Membership: (2) Adults age 31 or older that are married or share the same residence and up to 5 children/grandchildren ages 18 or younger

Young Adult: (1) Adult age 25-30

Mid Junior*: (1) Adult age 18-24

College*: (1) Full-time college student age 18-22 (proof of full-time enrollment required upon registration)

Junior*: (1) Junior golf age 18 or younger

Legacy Memberships: Individual members and Young Adult members may add up to 5 children/grandchildren to their membership for an additional \$100.00/child.

"Senior Discount": Members age 75 or older with at least 10 consecutive years of membership will receive a 10% reduction in annual dues

"Super Senior Discount": Members age 80 or older with at least 25 consecutive years of membership will enjoy membership at no cost

Benefits of Membership

Members of the Malone Golf Club enjoy unlimited use of the facility and practice areas, 10% off food in the Grille Room and Malone Golf Club embroidered apparel in the golf shop. Members can also take advantage of locker rentals and on-site bag storage. GHIN handicap subscriptions (required for participation in league and tournament play) can be purchased for an additional fee.

House Accounts House accounts are a great feature at the Malone GC. A house account is an account that you can charge any purchase to and be billed monthly for those purchases. Statements are emailed out on the 1st of every month and the credit card on file will be billed automatically on the 15th of every month, giving you two weeks to review those charges. House accounts will be set up automatically for the main account holder on memberships with voting privileges.

Private Cart Fee Notice

Stored Cart Fee: Current private cart owners **only**. All gas carts stored on the Club's premises include unlimited gas for your cart. You will not have to bring your own gas to fill up your cart. Simply fill your cart up at the private cart pump located at the maintenance facility.

Trail Fee: Homeowners with property connected to the Malone GC property (4 and 5 West) will have access to the golf course via their own personal cart.

Rules and Policies

1. Members who store personal golf carts must agree to hold the club free of liability in the event of loss through fire, theft, damage, or other claims during the term of the agreement.
2. Owners of the golf carts will be responsible for any damage to golf course property or other property, equipment, or individuals from any cause whatsoever involving their cart.
3. Owners of golf carts are required to obtain and provide proof of adequate insurance to cover the equipment and liability.
4. Golf cart storage does not include maintenance of any type.
5. A valid driver's license is required to operate a golf cart.
6. Members are not permitted to loan their golf carts to other golfers
7. Eligible cart users: Only owners and their immediate family (Spouse and children) may share driving privileges.
